APAI ELECTS NEW OFFICERS

At the recent Annual Business Meeting, conducted in conjunction with the APAI Annual Training Conference in Orlando, the election of officers concluded and the results were announced. Pursuant to the APAI Constitution, the offices of President and Treasurer were on the ballot this year.

Jeffrey Peterson, Executive Officer of the Office of Hearings and Release for the Minnesota Department of Corrections was elected to a two year term as President. His office functions as the Department's Releasing and Revocation Authority.

President Peterson has worked for the Minnesota Department of Corrections for 39 years beginning in 1973 as a Probation and Parole Agent in Southern Minnesota and then, in Hennepin County covering several metro counties and contiguous rural counties.

In 1986, he was promoted to Community Services District Supervisor and managed the Shakopee, MN District Office for twelve years supervising all the DOC corrections agents within a large district in Central and Southern MN, which included multiple, out-of-state offices.

President Peterson has been a member of the APAI for fifteen years. Prior to his election as President he served as APAI Vice President. Previous to his election as Vice President, he served as APAI's Central Region Vice President.

David R. Blumberg, Chair of the Maryland Parole Commission, was elected to a two year term as Treasurer. Treasurer Blumberg was appointed to the Maryland Parole Commission in 2003 and was appointed Chair in 2004. He was reappointed Chair in 2010.

Prior to being appointed a Commissioner he worked many years in Corrections as a Correctional Librarian. He has served in a multitude of civic and professional organizations.

Treasurer Blumberg has been an active APAI member for many years and is a strong advocate for increased training opportunities. He also serves on the Professional Development Committee. In 2011, Blumberg was appointed by then APAI President Charles Traughber to fill an unexpired term of Treasurer.

Upon taking office President Peterson appointed **Rissie Owens**, Chair of the Texas Board of Pardons and Paroles to his unexpired term as Vice President of APAI. She will serve until the Annual Meeting in 2013. Vice President Owens previously served as Chair

of the Council of Paroling/Releasing Authorities (COPRA) and before that, as Southern Regional Vice President.

These three, along with **Jeralita "Jeri" Costa** of Washington State, who serves as Secretary of APAI, make up the elected officers of our organization.

Former President **Charles Traughber** will continue to serve the Association as Immediate Past President.

Also, upon taking office, President Peterson appointed **Connie Bisbee**, Chair of the Nevada Parole Commission, as Western Regional Vice - President, to fill the vacancy created by the resignation of Barbara LeMaire.

Please extend your full support and cooperation as these officers lead our organization.

APAI AWARDS

Each year APAI recognizes outstanding contributions to the field of parole, reentry and community corrections with four awards that are presented in conjunction with the Annual Training Conference. The award winners this year represented an especially deserving group of professionals.

Judge Sir David

Carruthers, was this year's recipient of the Ben Bear Award. Judge Carruthers practiced law for many years before being appointed to various judicial offices in New Zealand, including Chief District Court Judge from which he retired in 2005. He was appointed Chairperson the New Zealand Board in July of 2005 a post he held until June of this year.

He led the Board through important challenges and changes. He modernized it administratively, gave members better tools and put a strong emphasis on their training and professional development. He also reached out to the community as he recognized that there was a need to sell the Board's work.

He is an outspoken

supporter of parole and of restorative justice and a much sought after international speaker.

Charles Traughber was this year recipient of the Vincent O'Leary Award. Charles has served on the Tennessee Board of Parole for over 40 years, a large part of that time as its Chair. He has also served APAI for the past

four years as its President and held various offices before that. No one supports parole and the work of APAI as much as Charles Traughber.

He has steered the Tennessee Board through many changes and is never hesitant to improve his agencies operations through innovative and promising practices.

He has also seen APAI through a multitude of challenges dealing with changes in personnel and shrinking budgets.

Kermit Humphreys was awarded one of two APAI President's Awards bestowed by President Charles Traughber. Kermit is a Correctional Program Specialist at the National Institute of Corrections where he has served for

27 years.

The award was given to Kermit because of his pioneering work in parole and because of the significant contribution he has made to the field and his support of APAI.

In his time at NIC he has worked on a number of initiatives, including the Interstate Compact, Parole Decision-making and Revocation. The Transition from Prison to Community (TPC) Initiative is Humphries's latest endeavor and aims to incorporate systems collaboration from parole, the courts, prisons, and a host of community services to improve offender outcomes.

Edward Reilly was awarded the second Presidents Award given by

President Traughber this year. Ed is the former Chair of the US Parole Commission and has been an active supporter of APAI for many years. He currently serves as North Eastern Regional Vice President.

Ed first entered public service back in Leavenworth Kansas at the age of 26 when he was appointed to the Kansas House of Representatives. He followed this with seven consecutive elections to the Kansas Senate.

Ed has served on numerous Board and Commissions such as the Advisory Boards of the United States Sentencing Commission and the National Institute of Corrections. He remained an ardent supporter of

APAI even after his retirement from USPC.

Dr. Regina Shearn was awarded the Community Service Award for her work with the Florida International University Corrections Transition Program in Miami.

The purpose of this counseling-transition practicum is to provide the long-term offender, who is within two to three years of work release, parole, or completing his sentence, and preparing to reintegrate into the community, with a forum for post-survival skills and the meaningful dialogue and interaction necessary for their successful return to the community.

APAI congratulates all of these very deserving award winners.

2012 INNOVATIVE PRACTICES FORUM

At the 2012 APAI Annual Training Conference in Orlando, Florida, the Florida Parole Commission sponsored and produced a very informative roundtable discussion that included descriptions of several innovative practices that have been developed and are currently being utilized in several jurisdictions across the United States and the world. In keeping with the conference theme of *Practicing Smart Justice: Innovative Practices in Parole*, participants at the conference presented brief snippets about what they are doing "back

home' to improve the way in which they do business and provide better and more economical services to their constituencies.


